

The Court, having reviewed the Liquidator's Motion For Order Approving and Setting a Final Claims Bar Date For All Remaining SAIC Claims ("Motion"), and accompanying Memorandum in Support, proper notice having been given, there being no objections to said Motion and the time having passed for the filing of objections, and good cause appearing therefor, hereby:

ORDERS, ADJUDGES and DECREES that the Liquidator's Motion For Approval and Setting a Final Claims Bar Date For All Remaining SAIC Claims is approved in its entirety. The Final Claims Bar Date will not apply to the following litigation/appeal cases: (1) Robert E. Wilcox v. Buffington & Smith Contracting Co., Civil No. 920901617 (Third Dist. Ct.), Case No. 20060059-CA (Utah Court of Appeals); (2) Robert E. Wilcox v. Meadow Valley Contractors, Inc., Civil No. 940902066 (Third Dist. Ct.); (3) Robert E. Wilcox v. Anchor Wate Co., Permanent Concrete, Inc., and LeFarge Corporation, Civil No. 920901617 (Third Dist. Ct.), Case No. 20050324-CA (Utah Court of Appeals). The Court hereby sets a Final Claims Bar Date on all remaining SAIC claims, as prayed in the Liquidator's Motion, of December 28, 2006, and that the Liquidator send Notice of the Final Claims Bar Date to all Claimants and creditors with un-adjudicated and undetermined claims pending at the date of this Order. Any claims filed after the Final Claims Bar Date of December 28, 2006 will not be accepted or considered by the Liquidator.
